6. Institutional set-up for liquidity risk management

Mahaveer Finance India Limited (MFIL) has established an Asset Liability Management Committee ('ALCO') to monitor and mitigate its liquidity risk. The ALCO comprises the Chief Financial Officer. Furthermore, MFIL has formed a Risk Management Committee (RMC) to supervise and address various risks, including liquidity risks which includes the Independent Directors. The ALCO and RMC communicates with the Board at regular intervals.
